After the results of last year's match, Emergency Medicine was challenged to continue attracting the best and the brightest to the specialty. A call was sent for all representatives in the specialty, including professional societies, practicing physicians, faculty, residents, and medical students, to not only acknowledge the challenges in Emergency Medicine but also to embrace those challenges, find solutions, and be the best hope for our patients navigating an increasingly complex health care system. That call was answered, and the 2024 match results showed that, despite the challenges, Emergency Medicine is one of the most desirable specialties in the house of medicine. Once again, the best and the brightest are knocking on the door of a growing number of Emergency Medicine Residency programs. More than ever, the ABEM Board of Directors seeks to maintain the highest standards in certification for the almost 5,000 new grads each year.

## Becoming Certified Updates

After successfully launching MyEMCert in 2021, focusing on continuous learning for the certified physician, it was time to evaluate the process for becoming certified. After a three-year initiative and hearing from over 4,300 individuals, the ABEM Board of Directors was proud to announce the development of a new Certifying Exam launching in 2026.

After traveling to professional society meetings and hosting webinars announcing the Certifying Exam, many asked why we need such an assessment beyond the written qualifying exam. The answer is simple.

The new Certifying Exam, like the past exam, doesn't just assess cognitive skills and medical knowledge, but also assesses complex multi-step reasoning, judgement, thoughtfulness, and different knowledge, skills and abilities than the written exam.

### **Research**

ABEM saw the fruition of an amazing initiative to publish research that supports everything we do. This past year represented the highest number of articles published in peer-reviewed journals on subject matters ranging from performance burnout, association of the Oral Certification Exam and state disciplinary action, to the factors that impact Emergency Medicine income. We continue to fund positions for two National Academy of Medicine Fellows, and their contributions to the specialty continue to demonstrate the value of research leadership for the specialty, ABMS scholarship, and our patients.

Future research will include studying performance trends on the In-training Exam and the Qualifying Exam.

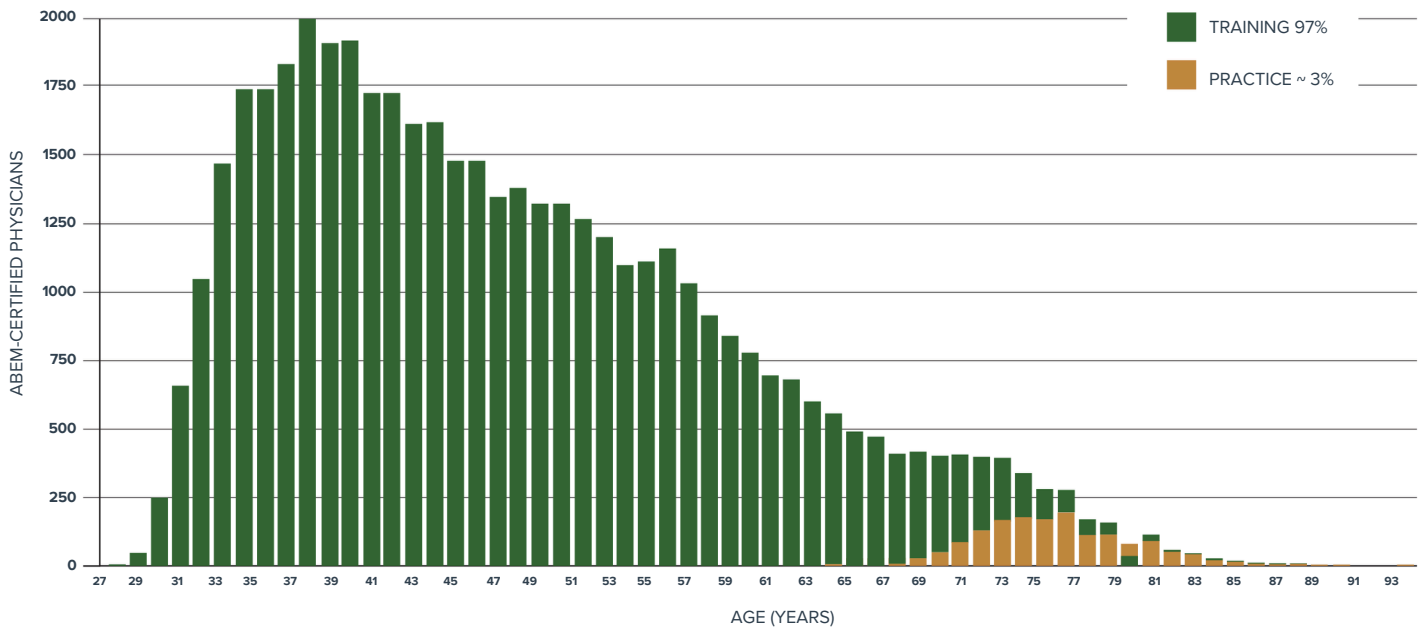

### Number of Current ABEM-Certified Physicians by Age Training and Practice Percentage by Live Current ABEM-Certified Physicians

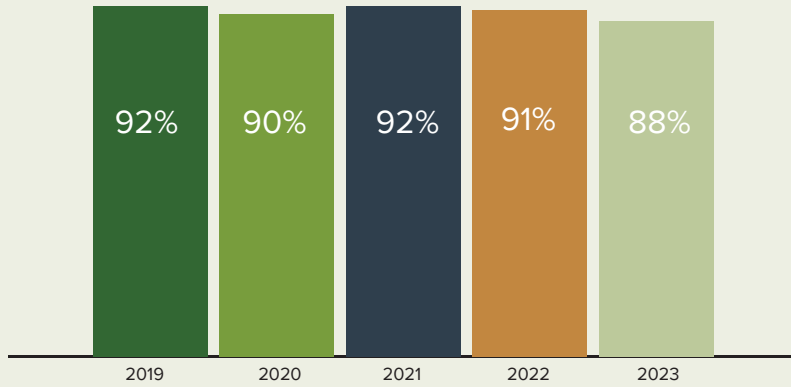

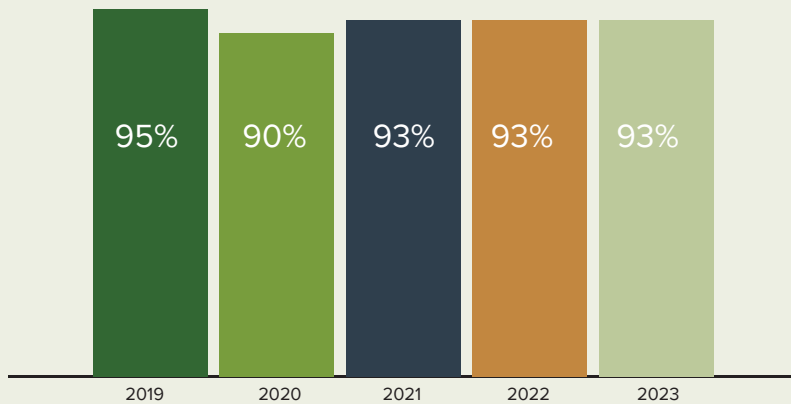

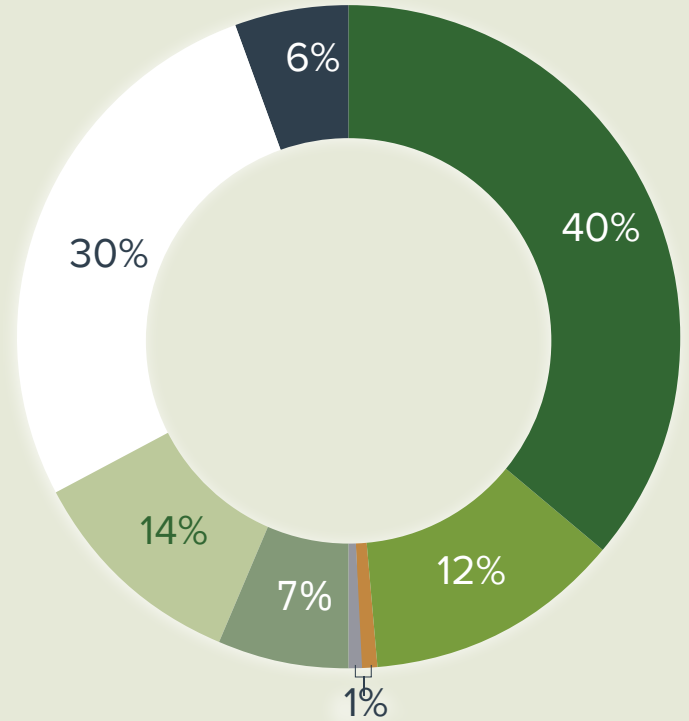

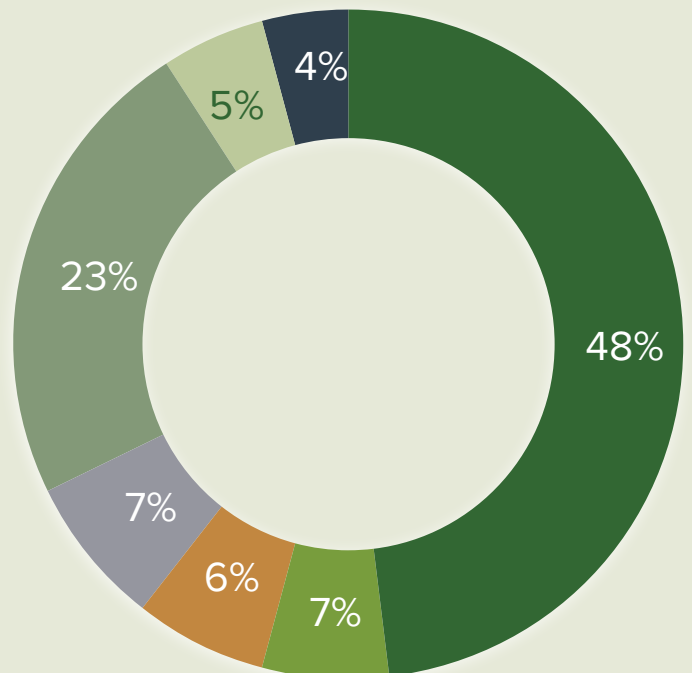
